To be eligible, a horse/rider combination will earn an average score of their 2 highest scores in one level, with one of the scores being test 4.

## BELT BUCKLE AWARD

Just like at the WDAA World Show, we will be offering a high score award for “**Silver Spur**” (horse/rider combination age equals 60 or more). Rider must show both days to be eligible.

*Please bring a copy for proof of age.*

Competition Rules: To be eligible to participate and/or compete as an exhibitor, owner, lessee, agent, coach, or trainer in any Western Dressage class at any Federation-Licensed Western Dressage Competition, persons must be active members of WDAA or pay a non-member fee equal to the price of an annual membership for each competition.” Proof of WDAA and WDAFL membership must be made available to Competition Management at a competition. If an individual is unable to present proof of membership, he/she must complete and sign a show pass form and pay a show pass fee of \$45 (adults) or \$30 (Juniors as defined in USEF Rule GR128).

Amateur Status: If you are entering amateur classes, you will need to provide proof of amateur status with your entry. If you do not provide proof of amateur status, you will be placed in the open division. Because this is a USEF recognized show, the only acceptable proof of amateur status is a USEF Amateur card. Please see <http://www.usef.org> for more information on obtaining an amateur card.

Junior Status: Riders are eligible to compete as juniors if they are 17 years of age or less at the beginning of the 2024 competition year (December 1, 2023 – November 30, 2024).

**ALL PAPERWORK, INCLUDING ENTRY, COGGINS, USEF/WDAA DOCUMENTS, ETC, MUST BE SUBMITTED ONLINE ALONG WITH YOUR ENTRY ON EVENTENTRIES.COM HARD COPY PAPERS ABSOLUTELY WILL NOT BE ACCEPTED.**

All entries must include proof of negative Coggins test within 12 months of show date, and USEF and WDAA documents for rider, owner, trainer and horse as appropriate for entry/classes. **Entries will not be processed without full payment**

**CONDITIONS OF ENTRY:** Every horse and pony entered for competition will comply with the rules of the horse show management, but the show management will, in no case, be responsible for loss or damage that may occur, and it shall be a condition of each entry that each exhibitor should hold the horse show, the officials, the show employees, the show facility, it's directors, and employees, USEF, it's directors and employees harmless for any loss or accident to his horse, horse or equipment which may occur from accident, sickness, fire, or otherwise. Management reserves the right to cancel, combine or divide classes, or to change officials as it deems necessary. Decision of Show Management is final. Failure to enter the ring by scheduled time may incur elimination. This is the responsibility of exhibitor. Score sheets will only be given to riders of their authorized representatives after results have been posted.

**ENTRY CANCELLATIONS/REFUNDS:** Office fee is not refundable. Entries with cancellation on or before the closing date will receive 100% refund of all fees minus the office fee. NO REFUNDS (including stabling) after original Closing Date even if Closing date is extended. Management will not refund entries for shows cancelled due to severe weather, acts of God, or other such emergencies.

**LATE ENTRIES:** must be submitted on or before the closing date. Late entries will be accepted at the discretion of management and will incur a late fee of \$50 per horse/rider.

**FARRIER:** Information will be provided and posted in the show office

**VETERINARIAN:** On call – names and numbers to be posted at the office & in the show program.

**SCHEDULE:** Will be emailed out to the competitors and posted at the office by noon the day prior to the first day of the show.

**STABLING:** stalls and tack stalls will be assigned on a “first come, first serve” basis by receipt of entry. If the requested stall area is filled, competitors will be assigned to other stall areas. High quality permanent (12 x 12) stalls, all have full sliding doors and solid floors. Initial bedding (2 bags) is included. Additional bags of bedding available. Please preorder extra bedding on the entry form. Additional nights - \$50. All electric plugs and fans must have the proper “grounded plug”.

**SHARPS CONTAINER:** containers are located in each barn.

**ADULT AMATEURS PLEASE NOTE THAT IN ORDER TO HAVE YOUR SCORES RECORDED WITH USEF FOR USEF AWARDS YOU MUST BE A RECORDED ACTIVE AMATEUR WITH USEF & SUPPLY YOUR NUMBER WITH YOUR ENTRY**

**NO REFUNDS** after the closing date (**GR 311.1.7** exception “act of God” in which classes are canceled only those class fees will be refunded). Refunds before closing date will be issued for amount paid minus the office fee. Returned Checks will incur a \$50 return fee, if not rectified within 10 days the matter will be turned over to USEF for disciplinary action.

**AWARDS:** Ribbons will be awarded first to sixth place. Intro through Level 5 tests will be split AA, Open, Gaited and Youth *if entries warrant*. No awards will be mailed unless arrangements are made in advance through the Secretary.

**FREESTYLES:** Riders, please submit music on a CD to the announcer's booth the morning of your ride. Music

should be labeled with instructions and horse/rider names. Sound checks will be available.

**RIDE TIMES:** Tentative ride times will be available online at [wdafl.org](http://wdafl.org) by the Wednesday prior to the show. All ride times, including the pre-printed showbill, are to be considered tentative until noon the day before the show. Please check your ride times outside the show office, on the results board, for up-to-date times.

**ATTIRE AND EQUIPMENT:** USEF rules and guidelines will be used for attire and equipment. For more information please review the USEF rule WD 120 121 122 123 by clicking this link <https://www.usef.org/forms-pubs/NpmAWxkXY6M/wd-western-dressage>.

**SAFE SPORT STATEMENT:** Effective immediately, any competition with the start date of September 1, 2020 and later will be required to include the following Safe Sport statement in the Rules and Regulation section of the prize list: Reminder: All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. **ARENA INFORMATION:** Two dressage courts will be set up in a 375' x 212' covered arena with an improved clay/sand mixture. A grass area near the arena will be available for warm up and lunging. All intro and basic classes will be in a small ring 20x40. All other classes will be in a 20x60.

**RV HOOK UPS:** 30- amp electric service and water are available on a first come-first serve basis. Please add request on the entry form.

**GOLF CARTS:** are available for rent through Masters Golf Cars, Inc. 352-307-0111 Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions.

**MOTORIZED VEHICLE STATEMENT:** Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

**PERSONAL ELECTRONIC TRANSPORT DEVICES:** The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is



accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

**EQUINE VACCINATION RULE:** At Federation licensed competitions horses, more than 7 months of age, entering the grounds must be accompanied by documentation of Equine Influenza Virus and Equine Herpes Virus (Rhinopneumonitis) vaccinations within 6 months prior to entering the stables. Horses not in compliance with this rule may be required to leave the competition grounds upon request by Competition Management.

**DRUG TESTING:** All exhibitors are required to pay the USEF Drug & Medication fee of \$23 and are subject to being randomly drug tested at the competition. (For USEF shows only)

**ACCOMMODATIONS:** There are several hotels within 3 miles. Nearest location is just off Hwy 484 and I-75 which is south of the park entrance.

**FOOD AND BEVERAGES:** located on the grounds will be available through food truck vendors.

**MANAGEMENT:** Show management reserves the right to refuse, accept conditionally and/or cancel awards of prizes without claims for damages & change order of classes, cancel, split, or combine classes at its discretion if entries deem necessary.

**DOGS:** are welcome but must be on a leash no longer than 6', at all times. Any loose dogs will result in the owner being charged \$50 that will be donated to the local Humane Society. Any nuisance dogs will be asked to leave the grounds.

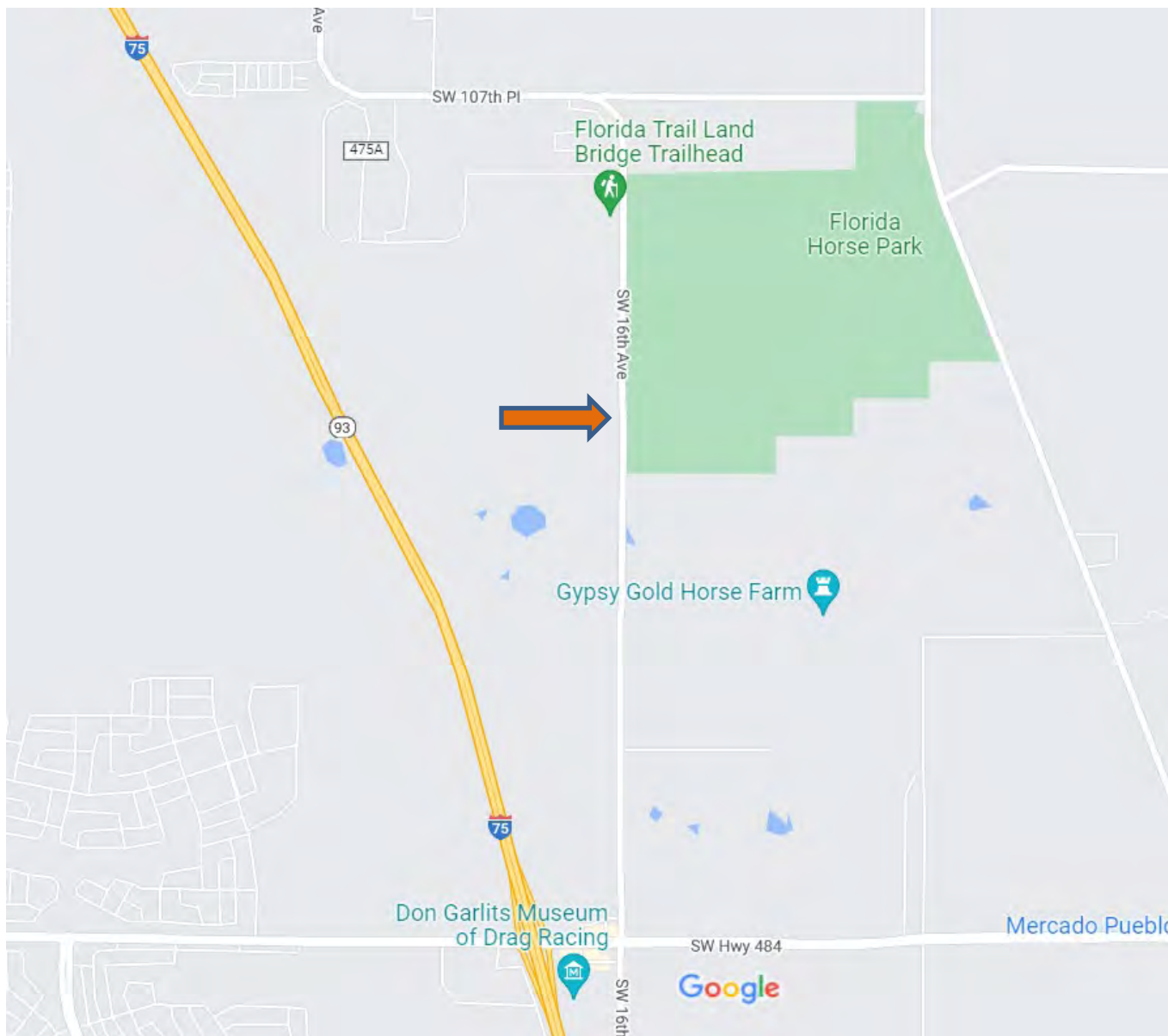
A Horse/Rider combination may enter no more than two consecutive levels, Freestyle levels included, at any one competition. Suitability, Hack and Equitation are excluded from the maximum limit of rides per day and horses in these classes may compete at any level for which they are otherwise eligible during the same competition. No horse may be ridden more than once in any Western Dressage class (including separate divisions or sections of the same class number). Horses cannot be ridden by more than two riders. Rides will be limited to 4 tests per horse, excluding suitability, equitation, and hack. If there is a conflict with breed division rules regarding WD102.2, the breed division rules will govern United States Equestrian Federation rules are in force from the moment show management allows access to the showgrounds. This includes conduct, correct saddlery and equipment, and attire. Exhibitors should also be aware of the USEF rules governing drugs and medications. Questions should be directed to the USEF Drugs and Medication Program. They may be reached at (800) 633-2472.

**NUMBERS:** must be worn at all times while a horse is out of their stall.

**Media Release Agreement** I agree that as a condition of and in consideration of acceptance of entry, the competition may use or assign photographs, videos, audios, or other likenesses of me and/or my horse taken during the course of the competition for the promotion or benefit of the competition or sport. These likenesses shall not be used to advertise a product and they may not be used in any way to jeopardize amateur status. I hereby expressly waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or misappropriation.



**DIRECTIONS:** 11008 CR 475A is the trailer entrance. **From I-75:** Exit #341, HWY 484, head east on 484 to SW 16<sup>th</sup> Ave, turn left onto SW 16<sup>th</sup> Ave. Park entrance on the right approximately 2 miles. **From Orlando area:** Take Fl turnpike (tolls) north towards Ocala merge onto I-75. Exit #341, HWY 484. Head east on 484 to SW 16<sup>th</sup> Ave, turn left. Park entrance on right approximately 2 miles. **From Jacksonville area:** Follow I-10 west, US 301 S and I-75 S. Exit 341, HWY 484, head east on 484 to SW 16<sup>th</sup> Ave, turn left onto SW 16<sup>th</sup> Ave. Park entrance on the right approximately 2 miles.

# WAIVER AND RELEASE OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

For and in consideration of United States Equestrian Federation, Inc. dba US Equestrian (“USEF”) allowing me, the undersigned, to participate in any capacity (including as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, official, trainer or volunteer) in a USEF sanctioned, licensed or approved event or activity, including but not limited to equestrian clinics, practices, shows, competitions and related or incidental activities and 2024 WDAFL Annual Show (“USEF Event” or “USEF Events”); I, for myself, and on behalf of my spouse, children, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors,, and assigns, hereby agree to and make the following contractual representations pursuant to this Agreement (the “Agreement”):

A. RULES AND REGULATIONS: I hereby agree that I have read, understand, and agree to be bound by all applicable Federation Bylaws, rules, and policies including the USEF Safe Sport Policy and Minor Athlete Abuse Prevention Policies as published at www.usef.org, as amended from time to time.

B. C.
